FUTURE NUPOINT ENHANCEMENTS – DEPOSITS

CF-85, Under Insured Deposit Report

Enhance the following:

- Beneficiary accounts
- ICS & Reich & Tang accounts
- Brokered Deposits
- Public Funds
- Collateralized/pledged accounts

DDA/SAV Requirements

This will be an optional display on the statements. It will show the count that was required to alleviate a SC or receive a reward.





FUTURE NUPOINT ENHANCEMENTS - LNS

LN Pmt to ACH

The loan/transfer system will handle the external payment as it does today; however, if the payment is returned, the user can identify the item as returned and mark it as a "Retry."

Basel IV

Three-year timeline for Implementation of this Risk-Weighted Asset regulation.

Escrow Deficiency vs. Shortage

Will allow banks to recoup escrow deficiencies in a shorter time frame than escrow shortages (2 – 11 months).
